Miss City of Palmdale Scholarship Pageants

Entry Rules and Regulations

1. **Age Requirements:** Contestants must be in their respective age groups by August 1st of the current calendar year. Little Miss contestants 6-8 years; Junior Miss 11-14 years; and Miss 16-20 years. Contestants must be willing to provide proof of age should questions arise.
2. **Residency Requirements:** Contestants must be a current resident and have been a resident of Palmdale for at least one-year prior and reside with one parent or legal guardian. Contestant should have reasonable assurance that she will remain in the community and be able to reign as queen for the entire year. Contestant must be willing to provide proof of residency.
3. **Pageant Activities:** The contestant shall attend the introductory tea, the final stage rehearsal, scheduled practices, and activities set forth by the pageant committee for each respective pageant. A point system will be used to track all activities. (See attached Pageant Contestants Requirement Sheet) In the event of a tie, the scores on this sheet will be used to break the tie.
4. **School:** All Miss City of Palmdale pageant contestants must currently be attending school, be enrolled in an academic home school program, have a high school diploma or equivalent. All contestants (all age groups) must carry and maintain a minimum 2.0 grade point average (GPA). Citizenship must be submitted with the complete entry form and will be required for all members of the royal court with each quarterly or semester report card throughout the year. This does not apply to college students.
5. **Sponsorship:** Each contestant must provide a minimum of \$250.00 in sponsorship fees. Sponsors may be family, friends and/or businesses. Those contestants obtaining additional sponsors, over the required minimum, will receive the following:

\$300.00-\$475.00	or	12-19 sponsors	\$50.00 Award
\$500.00-\$725.00	or	20-29 sponsors	\$75.00 Award
\$750.00-\$975.00	or	30-39 sponsors	\$100.00 Award
\$1,000.00+	or	40+ sponsors	\$200.00 Award
6. **Attire:** The Contestants must provide suitable attire as predetermined by the pageant committee. Attire will be discussed at the introductory tea.
7. **Antelope Valley Pageants:** It is mandatory for the newly crowned Little Miss, Junior Miss and Miss to participate in the Antelope Valley pageants. The Palmdale Chamber of Commerce will pay the entry fees for the newly crowned Queens to participate in their respective Antelope Valley pageants. Contestants will also be required to attend meetings, rehearsals, and fund-raisers as determined by the Antelope Valley Fair Board/or respective pageant coordinators. It is mandatory for Miss City of Palmdale to be available and present on all days of the Antelope Valley Fair.
8. **Miscellaneous:** Miss contestants must never have been married, have had any children, or be pregnant from the time she is selected Miss and throughout her reign. Contestants will conduct themselves in a sportsmanlike manner throughout the course of the pageant and pageant year.
9. **Failure to Observe** the above rules and regulations shall result in disqualification of the contestant's eligibility by the Palmdale Chamber of Commerce. All Queens will be expected to participate in community events and remain dedicated to the betterment of the City of Palmdale Community.
10. **Contestants and Their Parents** must conduct themselves in a positive manner at all meetings, all rehearsals, at the pageant, and after the results. Failure to do so will result in immediate disqualification of the contestant for all future pageants. Any questions, concerns, or remarks should be done in writing to the Palmdale Chamber of Commerce.
11. **Disqualification:** Any contestant not attending the mandatory tea, failing to turn in mandatory minimum sponsorship fees or not abiding by the above-mentioned rules will be disqualified.

Little-Junior-Miss City of Palmdale Pageant Contestant Requirements

The following is a list of the explanation of the points system.

Orientation Pageant Tea - February 21, 2010

- This is a mandatory function. Contestant will be disqualified if she does not attend.
- 5 points will be deducted if late.

Sponsorships

- Minimum sponsorship fee is \$250.00. \$100.00 of which is due at the beginning of the Orientation Sunday, February 21. The remaining \$150 is due March 8, 2010.
- If minimum sponsorship fees are not turned in by March 8, 2010, 5 points will be deducted.
- All remaining sponsorship fees are due by Monday, March 22.
- Any sponsorship fees turned in after March 22, 2010 will not be counted for Sponsorship Awards.

Pageant Practices and Dance Practices

- 1 point will be deducted each practice you are late.
- 2 points will be deducted for each missed practice.

Sponsorship Thank You Notes

- Minimum sponsorship thank you notes are due at the start of the first practice (3/1/10).
- All remaining sponsorship thank you notes are due with sponsorship fees on March 22.
- 5 points will be deducted if thank you notes are not turned in at required times.

Speeches

- Speeches for Little Miss will be turned in at the start of the 1st pageant practice (3/1/10)
- Speeches for Junior Miss and Miss will be turned in at the start of the 2nd pageant practice (3/8/10).
- 5 points will be deducted if late.

Bio Sheets

- Bio sheets are due at the start of the 1st pageant practice (3/1/10).
- 5 points will be deducted if late.

Dress Rehearsal

- 5 points will be deducted if you are late (4/16/10).
- 25 points will be deducted if you miss dress rehearsal.

Posters

- Posters are to be turned in at the beginning of dress rehearsal (4/16/10).
- 10 points will be deducted if late.
- 25 points will be deducted if not turned in.

Pageant Punctuality

- Mandatory arrival time will be given to the contestants.
- 10 points will be deducted if 5 minutes late.
